The Sindh Food Authority, Food Department, Government of Sindh invites sealed bids from interested bidders registered with FBR & other relevant tax authorities for the Procurement of Hardware and Development of Mobile Application for Sindh Food Authority. The requirements are as under:

Terms & Conditions:

- Single Stage- One Envelope Procedure would be used for procurement of Hardware through Open Competitive Bidding. Proposals should accompany a bid security equivalent to three percent (03%) of the bid amount in favour of "Sindh Food Authority". The bids must be sealed, and Envelope shall be marked as "**Proposal for Hardware**".
- Single stage, two envelope procedure would be used for **procurement of Development of Mobile Application Software along with support and maintenance** through Open Competitive Bidding. Proposals should accompany a bid security equivalent to three percent (03%) of the bid amount in favour of "Sindh Food Authority". The bids must be sealed, and each Envelope should be marked as "**Technical Proposal**" and "**Financial Proposal**" in bold and legible letters to avoid confusion. Initially on the opening date only Technical Proposals shall be opened and Financial Proposals of technically qualified bids shall be opened publicly and date and venue will be communicated to the bidders in advance.
- The bidding documents containing evaluation criteria and other relevant details may be collected on payment in the shape of pay order of Rs.1000/= in favour of "Sindh Food Authority" from office of the undersigned and can also be downloaded from www.ppms.pprasindh.gov.pk and www.sfa.gos.pk. The bids will be submitted / opened in the office of the undersigned. In case of downloading of bidding documents, pay order of Rs.1000 (One Thousand Rupees) may be enclosed with the bidding documents.
- Separate bidding documents may be acquired for each category.
- The bids prepared in accordance with the instructions in the bidding documents, must reach the office of undersigned as per above mentioned schedule.
- Bid security shall be forfeited to the Government if the bidder withdraws his/her bid after opening and before the expiry of the bid validity period or failed to sign the contract if the bid is accepted.
- Conditional bid and bid received without bid security shall not be considered.
- In case of undesirable circumstances on submission/opening date & time or if the Government declares a holiday, the tender shall be submitted/opened on the next working day at the same time & venue.
- The Procuring Agency may reject all or any bid as per relevant provision of SPP Rules 2010 (Amended 2019).
- The Procuring agency may cancel the bidding process at any time prior to the acceptance of a bid or proposal as per SPP Rules 2010 (Amended 2019).
