MINUTES OF THE MEETING OF THE PROCUREMENT COMMITTEE FOR FINANCIAL EVALUATION OF BIDS FOR THE PROCUREMENT OF EQUIPMENTS FOR CENTRAL FOOD TESTING LABORATORY OF SINDH FOOD AUTHORITY. VIDE N.I.T REF.NO INF/KRY/NO.1612/2024 DATED 21.05.2024 SPPRA SR NO.T00789-23-0004 22.05.2024.

A meeting of Procurement Committee (PC) was held under the Chairmanship of Director General, Sindh Food Authority, Food Department, Government of Sindh on 12th June, 2024 at 3:30 PM in the office of Director General Sindh Food Authority, Food Department at Bungalow No. 12-B Block-A S.M.C.H.S, Karachi . The meeting was convened to announce the technical evaluation results and opening of financial proposal for technically qualified firms for the Procurement of Equipments for Central Food Testing Laboratory of Sindh Food Authority. All members of PC were present in the meeting (Attendance Sheet of PC members is attached at Annexure-I).

The chair welcomed the Procurement Committee members and representatives/bidders of the firms. The PC thoroughly examined and evaluated the bidders qualification report of all bidders for above mentioned category as per eligibility/evaluation criteria as described in the bidding documents: The evaluation of bidders qualification is attached at (Annexure-II).

The PC thoroughly examined and evaluated the financial bids of the bidders and as per the prescribed criteria in the bidding documents. The PC thoroughly discussed item No.2 (FT NIR Spectrometer MPAII) which was quoted by M/s Kamstec International for Rs.85(M) (Eighty Five Million PKR Only) but after market evaluation it was found that the above machinery is available in the market in below price as per the quoted price by the bidder and it was also decided to re tender the whole procedure in the next Financial Year.

DECISSION: The PC Recommended cancellation and retender of said NIT as per section 25(1) of SPPRA rules, keeping in view the healthy and wider competition. The said decision shall be displayed and on the website of SPPRA and also on the website of Sindh Food Authority, Government of Sindh.
